Kent Showground Rules and Regulations

Show Times

- **All exhibits must be in place by 9.30 am and cannot be moved until 4.00 pm.**
- The Kent Showground is open from 7.30 am to 6.00 pm on Saturday, 31st March.
- The Show will be open to the general public from 10.00 am to 4.00 pm (9.00 am for auction viewing only).

Tickets

- All exhibits will be given the appropriate vehicle passes to gain access to the Showground.
- Each exhibit will be allocated with two entrance tickets to the Show.
- Additional visitor tickets can be purchased at the pre show rate of £5.00 per adult (£7.50 on the gate), under 12's free, preshow rate only available until Friday 23rd March 2012. Tickets can also be purchased from www.kentshowground.co.uk (January to 23 March only) or on the Exhibitor Application Form.

Insurance

- All vehicles and working machines must be insured against third party risks including use for off road and/or display use. Documentation must be brought to the Heritage Transport Show and Auction and may be checked by the appropriate steward.

Vehicle Restrictions

- Exhibits which date after 1980 will only be considered if of exceptional historic interest and at the discretion of the section steward.
- Due to the Showground holding the Kit Car Show; an event dedicated to kit cars on 7-8 April 2012, the Heritage Transport Show and Auction will be unable to accept any applications for kit cars irrelevant of age or manufacture.

Movement of Vehicles

- The road traffic act now applies to all places to which the public have access, therefore no unlicensed or under age driving is permitted.
- The speed limit on the Showground is 10 mph. This applies to ALL vehicles on the Showground. The one way system of the Showground must be observed at all times.
- Movement of all vehicles is restricted to travel to and from the ring or for permitted display purposes.
- If seatbelts are fitted on the vehicle they must be worn when travelling on the Showground.

General Regulations

- The placing of exhibits will be entirely at the discretion of the Society and their Stewards, although every endeavour will be made to meet any request made by an exhibitor.
- All persons must pay proper regard to the steward's instructions and should conduct themselves in a manner, which will not inconvenience other persons at the event.
