

## **Kent County Show Vehicle Pass Policy**

### **Please read carefully**

Over the last few years, we have noticed an increase in vehicles left on the showground during the Show, some authorised, but many unauthorised. As you can appreciate, a high number of vehicles on site heavily affects the appearance of the Show and has a knock on effect to our visitor's experience and perception of the Show. We therefore ask that any exhibitor wishing to enter the Kent Showground with a vehicle applies for the correct pass. This is also for security reasons and for your own safety while on the Showground.

Please read the below carefully and ensure you apply for the correct passes on the application form:

#### **Pre/post vehicle pass**

The purple car hanger will allow a vehicle access the Showground pre-Show (from the Monday prior until 6:00pm on the Thursday prior) and post-Show (from 6:30pm onwards on the Sunday). It will not allow a vehicle to enter the Showground during the Show.

There is no charge for this pass and all requests should be made on the application form. Please note the size of the stand booked will be taken into consideration when issuing passes.

#### **TS Delivery Pass (restocking)**

This pass will allow a vehicle to access the Showground each night of the Show, after 6:30pm for re-stocking purposes. Your vehicle will need to be off-site again before the Show opens at 8:00am. This pass costs £75 + VAT and should be applied for on the application form. Please note that security will be checking vehicles throughout the Show and any found on the Showground after 8:00am with a TS delivery pass will be liable to towing.

#### **Vehicle Entry – Cash Deposit Scheme**

This entry scheme is for exhibitors who need a vehicle on site to re-stock their stands between 6:30pm and 8:00am and do not wish to pay for a TS Delivery Pass. A £100 cash deposit is paid to security upon entry with a vehicle. This £100 is returned when the vehicle exits the Showground before 8:00am. Any exhibitors' vehicle found on the Showground after 8:00am will forfeit their deposit and their vehicle will be liable to towing.

#### **Static Vehicle Pass**

This pass will allow a vehicle to be onsite for the duration of the Show; a static vehicle pass will **only** be issued if the vehicle forms an essential part of the stand and the vehicle **MUST** fit within the space booked. Where possible we would also ask that this vehicle is hidden and not directly on display to the public. There is no charge for this pass and your request should be made on the booking form.

This pass will allow you to take the vehicle off-site each night, however the vehicle will have to be back in the Showground by 8am. **Failure to do so will result in security refusing your vehicle entry to the Showground.** Please note static vehicle passes will be issued at the discretion of the society and this pass is not guaranteed.

**Please note that all passes must be clearly on display at all times, failure to comply with this may result in your vehicle being towed offsite.**

*N.B All exhibitors will be issued with trade car parking passes for parking vehicles during the Show.*
