## Heritage Transport Show Rules and Regulations

### Classic of the Future Area

- This will be a limited area outside for vehicles that the Committee feel are appropriate. Your application does not guarantee acceptance into the Show.
- Entry into this area will cost £5.00. This will also admit two passengers.
- All vehicle should be manufactured post 1990.
- Exhibitors must include a photo and a description explaining why they feel their vehicle should be entered into this area.

### Show Times

- **All exhibits must be in place by 8.30 am and cannot be moved until 4.00 pm.**
- The Kent Showground is open from 7.30 am to 6.00 pm on Saturday, 7 April.
- The Show will be open to the general public from 10.00 am to 4.00 pm.

### Tickets

- All exhibits will be given the appropriate vehicle passes to gain access to the Showground.
- Each exhibit will be allocated with two entrance tickets to the Show.
- Additional visitor tickets can be purchased at the pre Show rate of £7.00 per adult (£10.00 on the gate), under 14's free, pre Show rate only available until Friday 6 April 2018. Tickets can also be purchased from [www.kentshowground.co.uk](http://www.kentshowground.co.uk) (January to April only) or on the Exhibitor Application Form.

### Insurance

- All vehicles and working machines must be insured against third party risks including use for off road and/or display use. Documentation must be brought to the Heritage Transport Show and may be checked by the appropriate steward.

### Vehicle Restrictions

- Exhibits will only be considered on this form if manufactured post 1990.
- For exhibits which were manufactured before 1990 please contact the Show Office for more information.
- Kit cars will be accepted at the 2018 Heritage Transport Show. They will be allocated space outside. They will be exempt from paying the entry fee for 'Classic of the future'.

### Movement of Vehicles

- The road traffic act applies to all places to which the public have access, therefore no unlicensed or under age driving is permitted.
- The speed limit on the Showground is 10 mph. This applies to ALL vehicles on the Showground. The one way system of the Showground must be observed at all times.
- Movement of all vehicles is restricted to travel to and from the ring or for permitted display purposes.
- If seatbelts are fitted on the vehicle they must be worn when travelling on the Showground.

### General Regulations

- The placing of exhibits will be entirely at the discretion of the Society and their Stewards, although every endeavour will be made to meet any request made by an exhibitor.
- All persons must pay proper regard to the Stewards' instructions and should conduct themselves in a manner, which will not inconvenience other persons at the event.
- Please include a self-addressed A5 stamped envelope with your entry form.
